

RESOLUTION NO. 12-96

Commissioner BOGAR introduced the following Resolution and moved its adoption:

RESOLUTION CREATING WATER, SEWER AND STREET IMPROVEMENT DISTRICT 12-10 OF THE CITY OF WILLISTON, NORTH DAKOTA.

BE IT RESOLVED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF WILLISTON, NORTH DAKOTA:

There is hereby created a Water, Sewer and Street Improvement District in the City of Williston, to be designated and known as **WATER, SEWER AND STREET IMPROVEMENT DISTRICT 12-10** created for the purpose constructing the following:

The construction of water and sewer system and a street along 50th Street from 9th Avenue West to 16th Avenue West

That said **WATER, SEWER AND STREET IMPROVEMENT DISTRICT 12-10** shall contain and involve the following described real property situated in the City of Williston, Williams County, North Dakota, described as follows:

A Tract of land located within Northwest Quarter of Section 2, T154N, R101W of the Fifth Principal Meridian, Williams County, North Dakota; more particularly described as follows:

Beginning at a point on the East-West Quarter of Section line of said Section, 33.00 feet East of the Southwest Corner of said South Half (S 1/2); thence North 00°00'10" East and parallel to the West Section line of said Section, 765.15 feet; thence due East a distance of 645.80 feet; thence North 04°50'00" East, 151.73 feet; thence North 89°50'40" East, 620.48 feet to the East line of the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of said Section; thence South 00°14'00" West along said East line, 166.89 feet; thence departing said line, North 89°54'13" East, 1327.33 feet to the North-South Quarter of Section line of said Section; thence South 00°00'15" East along said Quarter line, 747.87 feet to the Center Quarter Corner of said Section; thence South 89°52'10" West along the afore mentioned East-West Quarter of Section line, 2,605.00 feet to the Point of Beginning.

Said Tract contains a total 47.24 acres, more or less.

Said Tract is being platted as the Spring Brook Meadows Subdivision.

And

A Tract of land located within Southwest Quarter of Section 2, T154N, R101W of the Fifth Principal Meridian, Williams County, North Dakota; more particularly described as follows:

Beginning at the northeast corner of the Southwest Quarter of said Section 2; thence S00°06'11"W along the east line of the Southwest Quarter of Said Section 2 a distance of 1,323.31 feet; thence N89°59'15"W a distance of 1,319.08 feet; thence N00°07'05" a distance of 1,322.56 feet; thence N89°58'48"E along the north line of the Southwest Quarter of said Section 2 a distance of 1,318.74 feet to the Point of Beginning.

Said Tract contains a total of 40.1 acres, more or less.

Said Tract is being platted as the Renaissance Heights Subdivision.

As shown on the attached map.


