

RESOLUTION 13-135A

Commissioner Cymbaluk introduced the following resolution and moved its adoption:

RESOLUTION AUTHORIZING ESCROW AND DISBURSING AGREEMENT

WHEREAS, the City of Williston is a North Dakota Home Rule Charter City pursuant to Chapter 40-05.1 of the North Dakota Century Code; and

WHEREAS, N.D.C.C. § 40-05.1-06 (2) and (16) authorize North Dakota Home Rule cities to control their finances and fiscal affairs and to levy a sales and use tax; and

WHEREAS, the City of Williston has authorized the levy of a sales and use tax by enactment of Ordinance No. 742, as amended by Ordinances No. 779, 846 and 921, all relating to extending the City of Williston's sales and use tax; and

WHEREAS, the City of Williston, by resolution No. 13-094, has dedicated a portion of the sales and use tax to the debt service of Sales Tax Revenue Bonds, **Series 2013A** and Sales Tax Revenue Bonds Series **2013B** (hereinafter the 2013 Sales Tax Bonds); and


WHEREAS, the City Commission, on June 25, 2013, approved a preliminary resolution authorizing the issuance of the 2013 Sales Tax Bonds; and

WHEREAS, as part of the 2013 Sales Tax Bonds transaction, the City must enter into an Escrow and Disbursing Agreement with the Bank of North Dakota.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Williston, North Dakota, as follows:

1. The City Commission hereby authorizes the President of the Board of City Commissioners and City Auditor to execute said Escrow and Disbursing Agreement by and between the City of Williston and the Bank of North Dakota.


