RESOLUTION 14-051

RESOLUTION ACCEPTING AN EASEMENT FOR PUBLIC STORM DRAINAGE FOR A TRACT OF LAND SITUATED IN THE SE¼ OF SECTION 9, TOWNSHIP 154 NORTH, RANGE 101 WEST 5TH P.M., CITY OF WILLISTON, WILLIAMS COUNTY, NORTH DAKOTA

The following Resolution was offered by Commissioner Bettedahl and seconded by Commissioner Cymbaluk, who moved its adoption.

WHEREAS, The City of Williston, on the 9th day of September, 2014, entertained a request to from _____, to accept an easement for public storm water drainage as shown in Exhibit "A", situated in Section 9, Township 154, Range 101, Williams County, North Dakota to wit:

Lot 9, Block 42, Harvest Hills Subdivision, a Rearrangement of Lot 1, Block 23, Harvest Hills Subdivision, in the NE¼ and the SE¼ of Section 9, Township 154 North, Range 101 West, 5th P.M., in the City of Williston, Williams County, North Dakota, as more particularly described in the attached Exhibit A,
