ADVERTISEMENT FOR BIDS

CITY OF WILLISTON
WATER AND SEWER IMPROVEMENT
DISTRICT 10-5

NOTICE IS HEREBY GIVEN that the City of Williston will receive sealed Bids for the construction of two separate Sections of Water and Sewer Improvement District 10-5 in Williston, North Dakota at City Council Chambers, Williston City Hall, 22 East Broadway, Williston, North Dakota, until 3:00 PM, Tuesday, August 17, 2010, at which time all Bids will be publicly opened and read aloud.

Bidders shall submit separate bids for each section of work described in the Contract Documents. All Bids must be submitted, and all work shall be done, in full and strict compliance with the Plans and Specifications for this project.

Copies of the Project Manual, including Plans, Specifications, Bidding Documents and Contract Documents may be obtained from AmeriTech Engineering Corporation, 107 Main, Williston, North Dakota, 58802, Ph: (701) 577-4127; upon payment of fifty dollars (\$50.00) for each set of documents, none of which will be returned.

The general Work covered by the Plans and Specifications for Water and Sewer Improvement District 10-5 is the materials, labor, tools and equipment required for the construction of the following approximate quantities in each section of the District. Bidder shall refer to the Bid Form in the Project Specifications for actual plan quantities.

Section I – Sanitary Sewer 23rd Street West: 1 LS - General Conditions; 1 Ea - Connect to Existing 12" Sanitary Sewer; 1360 LF - 12" Sanitary Sewer Main; 66 LF - 8" Sanitary Sewer Main; 31 Ea – 12" x 6" Sewer Service; 6 Ea – Standard Manholes; 1 Ea – Lamp Hole.

Section II – Water Main 23rd Street West: 1 Ea – Connect to Existing 8" Water Main; 1440 LF – 8" Water Main (SDR 21); 35 LF – 6" Water Main (SDR 21); 8 Ea - 8" Gate Valve w/ Box & Riser; 3 Ea – Fire Hydrant Assembly; 3 Ea – 8 x 6 DI Tee; 1 Ea – 8 x 8 DI Cross; 4 Ea – 8" DI 22 ½ Bend; 2 Ea – 8" DI 11 ¼ Bend; 3 Ea – 8" DI Plugs; 31 Ea – 8"x1" Water Service.

All Bids are to be submitted on the basis of cash payment for the Work and Materials, and are to be enclosed in a sealed envelope addressed to the undersigned Mayor, accompanied by a separate envelope containing a Bidder's Bond in the sum equal to 5% of the full amount of the Bid, executed by the Bidder as Principal, and by a Surety, conditioned that if the Principal's Bid is accepted and the contract awarded to the Principal, the Principal, within ten days after notice of award, shall execute a Contract in accordance with the terms of the Bid and Performance and Payment Bonds as required by the law and the regulation and determinations of the Owner. Countersignature of a Bid Bond is not required. Bidders shall be licensed for the full amount of the Bid, as required by Section 43-07-05 of the North Dakota Century Code.

No Bid may be read or considered if it does not fully comply with the requirements of Section 48-01.1-05 of the North Dakota Century Code. Any deficient Bid received will be resealed and returned to the Bidder immediately.

The Owner reserves the right to hold all Bids for 30 days, to reject any or all Bids and to waive any informality or irregularity in any Bid and to accept the Bid deemed in the best interest of the Owner.

There shall be endorsed upon the outside of the envelope containing the Bid, the following: (1) "City of Williston, North Dakota – Water and Sewer Improvement District 10-5; (2) The name of the person, firm, corporation, or joint venture submitting the Bid; (3) The Bidder's Contractor's License or Contractor's License Renewal Number. A copy of the Bidder's Contractor's License or Contractor's License Renewal shall be included in the Bid Bond envelope along with the Bid. (4) Acknowledgement of the Addenda.

All Work shall be complete and ready for final payment in accordance with the General Conditions by October 29, 2010. Bidders shall refer to the Project Specifications for provisions regarding liquidated damages.
